1. <u>STEEL CITY FIRE COMPANY – 2121 RIVERSIDE DRIVE – VARIANCE FOR REAR YARD SETBACK</u>

Mr. Chris Snyder said they are looking for a side yard setback to house equipment. Mr. Garges said it's the rear yard setback. Mrs. Louder asked what was the size and Mr. Snyder said 26'x50'. Mrs. Louder said there's a propane tank in the rear of the fire department and she's sure it's been there a long time, that it is sinking from the trains going by and has a problem with the propane tank. Mr. Snyder said it is not from the trains it is from water runoff, but everyone who looked at it said there was no concern. Mrs. Louder asked where was the existing shed? Mr. Snyder said it was already removed and was to the rear-right of the station; the new shed would be placed there as well. Mrs. Louder asked what would be placed inside and Mr. Snyder said it will house their equipment that's currently standing outside. Mrs. Louder questioned if vehicle would be able to fit past the shed and Mr. Snyder said yes they can. Mrs. Louder asked what are the plans for the repairs to the existing building? Mr. Snyder said he can't answer that at this time; he's here for a variance on a shed, not reconstruction of the building. Mrs. Louder said she's concerned about a new structure being put there and the old structure isn't being taken care of. Mr. Snyder said he will keep her updated when that time comes. 2. SIDNEY GROSMAN – 1454 CLAUSER DRIVE – VARIANCE FOR FENCE HEIGHT

Mr. Garges said the property is at the corner of Clauser and Route 378. The applicant already installed a fence after he bought the home, and didn't understand he needed a permit. He has two front yards, and excessive noise and light glare from Route 378, so he erected the 6' fence to protect himself, and he plans to plant some trees.
