### A. COUNCIL ROOM A/V SYSTEM QUOTE

Mr. Sostarecz said the AV system in the Council room has not been functioning for the past couple of months. The Township received a quote from AVT and Bruce MacLelland was present to speak about the system. Mr. MacLelland said he took a look at the room and examined all the needs. He gave a summary on the proposal he provided to the Township and said there's a lot of flexibility with the system. The quote for the system is \$28,860.00.

## B. <u>ORDINANCE NO. 2017-01 – OPEN SPACE EIT – REVIEW AND AUTHORIZE ADVERTISEMENT</u>

Attorney Treadwell said it is Chapter 150 of the Code of the Township, which is the taxation section. He reviewed three of the changes he made to the ordinance. Mrs. Louder asked how much was in the open space fund as of January 2017 and Mr. Horiszny said more than \$5 million.

**MOTION BY:** Mrs. Louder moved for approval to authorize advertisement of Ordinance No. 2017-01,

amending Chapter 150-2(C) of the Code of the Township of Lower Saucon to revise the provisions relating to the Open Space municipal resident tax in accordance with the November

2016 referendum results.

### C. <u>PA DEPT. OF HEALTH – IESI HEALTH CONSULTATION – AUTHORIZE REVIEW BY</u> TECHNICAL CONSULTANT COMMITTEE

Mr. Horiszny said at the request of the Township in 2015, the PA Dept. of Health conducted a study of the odor complaints in Steel City regarding IESI. The final Health Consultation report was received and Council may wish to direct the report be reviewed by our consultants and that a cost estimate to do so should be provided. Mrs. deLeon said she would like this reviewed and would like some recommendations and things to follow up on. The report was inconclusive because of the testing equipment that was being used. She thinks we should send a letter to the consultants who did this study thanking them as we asked them to do a service and it does give us direction.

Mrs. Louder said it states in the conclusion that the DEP and Board of Health were not able to come to a conclusion and their recommendation is to re-do the study and use the proper equipment to get the valid information that they need and move forward from there. She is not in favor of paying our TCC to challenge doctors, DEP and the Department of Health. She wants to take their recommendation and have a new study completed with more rigorous and analytical methods being used. Mr. Kern said he agrees with Mrs. Louder.

Mrs. Yerger said we may want to put in the letter if they can determine the timeframe. Attorney Treadwell said the chance is the TCC will say they didn't use the right equipment. He doesn't see any reason not to give the TCC a copy of the report, but don't pay them for an extensive review. Mrs. deLeon said the treatment plant should follow these recommendations.

Mrs. Louder said Lauressa stated the report was inconclusive; all it does conclude was that there are odors in Steel City. Mrs. deLeon agreed and stated she hasn't smelled any odors for a long time from the landfill. Mrs. Louder said there was a leachate odor in her backyard and DEP came out as well as IESI. She asked if the two residents with wells are aware of the findings of the study as she would like them notified. Mrs. deLeon asked the Township to send the two residents the study.

MOTION BY: Mrs. Louder moved to authorize the Manager to send a letter to DEP and the Department of

Health to perform a new study using the more sensitive odor detection equipment that is

referred to in the report.

**SECOND BY:** Mrs. deLeon

**ROLL CALL**: 5-0

MOTION BY: Mrs. deLeon moved to authorize management to forward the report to the TCC for their use

going forward with recommendations to the landfill.

No second, the motion did not pass.
