# I. OPENING

<u>CALL TO ORDER:</u> The General Business & Developer meeting of Lower Saucon Township Council was called to order on Wednesday, April 18, 2018 at 7:02 p.m., at Lower Saucon Township, 3700 Old Philadelphia Pike, Bethlehem, PA with Mrs. Sandra Yerger, presiding.

# ANNOUNCEMENT OF ANY EXECUTIVE SESSION (IF APPLICABLE)

Mrs. Yerger said Council met in Executive Session prior to this meeting to discuss potential property acquisition under the Open Space program on County Line Road; there is no action necessary at this time.

### PUBLIC COMMENT/CITIZEN AGENDA ITEMS

Mrs. Yerger said if you are on the agenda, you have Council and Staff's undivided attention. If you do choose to speak, we ask that you use one of the microphones and state your name for the record. She asks that you give your fellow public the courtesy of the floor.

# II. PRESENTATIONS/HEARINGS

# A. <u>PENNDOT PUBLIC INFORMATION SESSION – EASTON ROAD/SAUCON CREEK PIPE REPLACEMENT PROJECT</u> (7:04 p.m.)

Brian Garman and Will Delauter, NTM Engineering Design Consultant for PennDOT and Joe Petrakovic from PennDOT District-5 were present. The project is on Easton Road between Countryside Lane and Ringhoffer Road and is to replace the existing 48" corrugated pipe network that runs below SR2006. The existing pipe was around 210' and has since deteriorated and resulted in a loss of 40'. The proposed solution is to replace the pipe with a single 72" diameter pipe. Upstream they are replacing a standard type headwall; downstream they are replacing a USBR Type 6 impact basin. Portions of the upstream and downstream channel will be stabilized to prevent erosion. They will replace the pavement, the guiderail and right-of-way fence. Everything will be within the public right-of-way.

A detour is proposed, which will be on State Route 412, Shimersville Road, Applebutter Road and Lower Saucon Road; for between 3 and 4 weeks. The East Branch Saucon Creek supports natural reproduction of trout, and they are less than ½ mile from that, so work is restricted between October 1 and 31<sup>st</sup>. There will also protect high-quality wetlands. They discussed utility relocation as well.

They will coordinate with the SV School District and the postal service regarding the detour, as well as emergency services. Construction will begin early 2019. They will provide survey forms in the Township's lobby, where plans will be on display.

Mrs. Louder asked why the pipe size is being changed? Mr. Garman said so the hydraulics can contain more flow, which is necessary, there's no extra water. Mrs. Yerger said there has been flooding issues where Ringhoffer joins with Easton Road, will this increased volume of water with the bigger pipe make that worse? Mr. Garman said their analysis does go upstream and downstream and they are not in any type of FEMA floodway; he can get more information for the Township. Mrs. deLeon asked if you make something bigger, won't there be more force to it? Mr. Garman said that's why they are doing an impact basin as that will dissipate the energy. Currently, the flow isn't going through the pipe, it's going under it. Mrs. Louder asked what kind of traffic the project will generate and about the power lines? Mr. Garman said there will be equipment and cranes mobilized to the project area and some other equipment, but it won't be excessive, he said the lines are just guy wires.

Mrs. deLeon had concerns with the water coming down and creating a big void. Mrs. Yerger said it's a substantial grade. Mr. Garman said it begins to flatten out and there's a pond at the bottom of the embankment. The pond was a detention basin created as part of I-78 and they aren't putting any more flow into it. The scope of work is to rectify the problems. Mr. Kocher said the same amount of flow coming through there now is going to come through the 72" pipe, so the velocity should be less, and the dissipation structure is a good design which does knock a lot of energy out.

Mr. Allan Johnson asked if the water that is going to be coming through this pipe is coming from I-78? Mr. Garman said yes. Mr. Johnson asked if the pipe that brings it down from I-78 will be replaced? Mr. Garman said this project is confined to Easton Road.

# B. <u>MUNICIPAL SEPARATE STORM SEWER SYSTEM (MS4) PROGRAM UPDATE – POLLUTANT REDUCTION PLAN SUBMISSION</u> (7:27 p.m.)

Mr. Jason Smith with Hanover Engineering was present to discuss the Pollutant Reduction Plan (PRP) which was created because of DEP's MS4 program. This plan is required for the next permit round which will be from 2018 to 2023; LST has an individual permit. The planning area is approximately 1.65 square miles; about 33% of LST's urbanized area is considered the planning area. That area is the drainage areas to LST's MS4 regulated outfalls and drain water from Township facilities to streams and wetlands. It is DEP's charge to reduce 10% of the sediments that currently leave those Township lands draining to these points. The first step is to make sure they have all 38 regulated outfalls properly categorized and select a method that is consistent with the EPA's guidance on the existing load of sediments, which looks at using land area that drains to each outfall and the land cover within those drainage areas.

They looked at Best Management Practices (BMPs) within those drainage areas for opportunities to retrofit or install new BMPs that would help reduce the sediments. The plan will be amended over time and they can choose the best basins to retrofit and do them the cheapest way. They will know more after DEP reviews this plan and provides comments. They will take the comments from the Township, the EAC, and the public until April 25, 2018. Mrs. deLeon said in Steel City, there's a big area that's green and it's not really a park. Mr. Smith said there are lands designated as parks that are not necessarily Township parks, so it may be public lands; they can look at changing the terminology. Mrs. Yerger said the EAC is working on some educational components. They just made a flyer for one of the MS4 compliances.

Mr. Kocher said one thing the plan mentions is the cost of improvements. The State said we are responsible to do this, but we don't yet know the total cost because we need DEP to say the plan is okay. Once they agree to the ideas that we have to reduce the sediment, we can prepare cost estimates, then you have to figure out how to pay for them. The State has given options and one is to implement a storm water fee or you could impose a tax increase. Mr. Smith said they will work on reducing the BMP costs.

#### В. POLK VALLEY PARK - 2068 POLK VALLEY PARK - REQUEST FOR WATER SERVICE FOR PUBLIC WORKS USE (7:51 p.m.)

Mrs. Huhn said we are requesting approval to utilize an existing water line to install a lockable water hydrant near Polk Valley Park in the area where the house was removed which would be supplied by Hellertown Borough Authority. Mr. Rasich said there is already a service line that used to go to the house and they could re-utilize that. This is to help service their equipment while they are out there.

Mr. Rasich said if it is desired in the future, water could possibly be extended up to the dog park. Mr. Stauffer said the P&R Board discussed their desire to have a snack stand that serves hot food, and to do so they need running water, so they asked about the possibility of running the line further up. It appears to him that it is a long way and would probably be costly. Mr. Rasich said to get it to the dog park is relatively easy; however, he's not sure if the existing service line is capable of providing enough pressure to get it to the dog park. Mrs. Yerger said when she goes to the dog park, everyone brings their own jugs of water. Mrs. Gorman said the funds could come from the parks general maintenance.

They have been working on the trimming of the brush; however, the final roads got pushed off a bit and he is finalizing it. They will take care of about 7 miles of road, but would like to get that closer to 10 miles but it's based on available manpower. Mrs. Huhn said they are hoping to get an earlier start this year and she'd like to get some part-time seasonal help for the summer.

# A. TOWNSHIP MANAGER

- She spoke about the Meadows Road Bridge under Mr. Kern's report.
- A notice has been posted in the PA Bulletin that UGI Energy Services has applied for a permit from DEP to construct and maintain water encroachments associated with their project. There is a 30-day comment period which will occur prior to our next meeting. Mrs. Yerger said if it floods it's coming upstream, and we certainly have concerns about the construction of the road into the floodway, into crossing the stream, storm water facilities, so have HEA write a letter and submit them before the comment period. Mr. Kocher said you could contact DEP and tell them your comments are within the 30-day comment period and an additional letter will be forthcoming.

# Mr. Kern

We received a letter regarding the construction of the Meadows Road Bridge, which is good news as they are applying for a grant and it's for the rehabilitation of that bridge. We have a 30-day comment period and he'd like to stress in the comments that we are in favor of rehabilitation and reconstruction of the bridge. Mrs. Huhn said she agrees with Mr. Kern; on April 5<sup>th</sup> she received a call from Tom Kohler from NC and he said the bridge was being closed immediately because of serious deterioration. On Monday, they received the notice that Mr. Kern just spoke about. They are submitting an application to DEP for a general permit which covers maintenance, testing, and repair or replacement associated with the bridge. She would like to submit our own comments and stress we want to see the bridge rehabilitated. She contacted Andrew DeGruchy who conducted a site visit in 2008 and he gave us some recommendations. They recently discussed what assistance he could provide the Township in working along with the County as they move forward with this. He is willing to prepare another report and conduct a site visit. His concern is if we are taking something to the County, he would want a credential person to go along.
