B. ZONING HEARING BOARD VARIANCE – MICHAEL & PAULA MARTINKO – 1916 LEITHSVILLE ROAD – VARIANCE FOR SIDE YARD SETBACK FOR A GARAGE

Mr. Martinko was present. He said they are trying to build a garage and ten years ago when he built an addition, the setbacks were different; currently they are 30°. If he does build 30° from the boundary line it will encroach upon the sewage and storm water pipes. If he can have a 15° setback instead, he'll be good; all the neighbors were notified. The area is not sloped and the water would be directed to the backyard. Council took no action.

C. REVIEW OF TOWN HALL PAINTING BID RESULTS

Mrs. Huhn said we put out for bid the painting of Town Hall and doors at Seidersville Hall. The bids were opened on September 1, 2017; four bids were received and staff is recommending the low bid from Ryan Amato Painting of Easton, PA at a price of \$19,010.00, which covers the material and labor for Town Hall, the carport, and doors at Seidersville Hall. The other bids were in the range of \$47,000 to \$69,000.

A. MANAGER

- Saturday, September 9th is the Stuff the Truck event at LST from 9:00 a.m. to Noon.
- Steel City Park is nearing completion so she'd like to discuss some dates for a grand opening and ribbon cutting ceremony. Mrs. Louder said a Saturday would be appropriate, maybe October 7th. Mrs. Huhn said check your calendars and she'll get back to everyone.
- The SV Spirit Parade will be October 22nd and we will be getting a truck, so if any Council member wants to ride in the truck, let her know.
- We received a quote on the removal of the dead trees discussed at the last meeting. The quote was \$8,832 for the trees, which is over the original quote of \$5,532 from All Season Tree Care. If Council approves the lower quote, we will contact the property owners, then have the trees taken down. She did some research and spoke with our Planner and Arborist on the removal of the ash trees, and since the whole area is under quarantine in PA, we can take these to our compost center, and it won't spread any infestation.

- Tomorrow night at Revolutions, 5:30 p.m. to 7:30 p.m., there will be an event, "Christmas in September" sponsored in part by the Chamber.
- She met with the Bethlehem Mayor to talk about traffic issues; Hellertown and our engineers were there.
- She asked Linc that when a developer is before us, and the developer meets all the conditions, it's hard to say no to that, so can you explain why? Attorney Treadwell said the land development approval is an acknowledgement that the application meets all the requirements of the subdivision ordinance, but sometimes there are waivers discussed and granted or not granted. Mrs. deLeon said we took an oath saying we had to follow the law and the law says if they meet all that conditions we have to basically vote yes, whether we like to or not. Attorney Treadwell said correct.

- She would like to revisit the properties in the Township that are not maintained properly. The City of Allentown has a program called the Rehabilitation and Maintenance which they have a set of criteria and properties are called in and reported; someone is sent out and it's investigated. Fines are given if it's not cleaned up. There are some properties in the Township that have holes in the roof and now there are buzzards living inside. Attorney Treadwell said this issue was discussed previously, and if we as a Township adopt that code, there are going to be an extremely large number of properties who will immediately be in violation of that code, which becomes an issue. Mrs. Louder asked to giver her the opportunity to bring in the information she has.
- On Saturday at 7:00 a.m., she called IESI because on the prior Thursday she had horrific garbage smells in her yard. DEP was notified and she never got a call back. She requested a tour of the landfill. Mr. Hallock was not on site, but Dee was happy to call him. By 7:30 a.m. she had a phone call from Mr. Hallock from NY. He said at 9:00 a.m.

she was welcome to go on a tour, so she went and the work face of that landfill is higher than anything else. The temperatures are changing, it's cooling down at night, and whatever is floating in the air is dropping down on the property owners. She thinks they dropped their standards. Council passed the land development plan on June 15, 2016, and she would like it noted she did not vote yes on any of that.
