E-Waste Recycling Options

1. Check with the equipment manufacturer or retail outlet to see if a take-back, drop off, donation, or mail-back program is available.
2. Take the equipment to a local electronics recycling facility.

For your convenience, the Department of Community and Economic Development will be hosting a special e-cycling event where many electronic items can be recycled without charge. There is a nominal fee for the items listed below (cash only, paid directly to AERC).

TVs	\$ 20.00
CRT Monitors	\$ 10.00
LCD Monitors	\$ 5.00
Batteries, all types except lead acid	\$ 0.75/pound
Batteries, Lead Acid	free
Fluorescent Lamps	\$ 0.25/each
Ballasts	\$ 0.75/pound

Below is a list of Electronic Materials Accepted by AERC for Recycling and Recovery.
We enforce a Zero-Waste-to-Landfill Policy.

ACCEPTABLE MATERIALS

COMPUTERS, MONITORS & TELEVISIONS

- Computer monitors (CRTs, Plasma and LCD displays)
- Laptop and notebook computers
- Televisions (standalone, console, wide-screen, projection-screen, CRT, Plasma, LCD)

COMPUTER EQUIPMENT

- Computer systems (CPU units)
- Computer peripherals (printers, scanners, plotters, copiers)
- Computer accessories (keyboards, mice, speakers, cords, cables)
- External disk memory and hard disk drives*
(*confidential data destruction available)
- Circuit boards and electronic components/chips
- Network hubs, modems, and routers

OFFICE & BUSINESS EQUIPMENT

- Photocopiers and multi-use copiers (copy, fax, scan, print)
- Telephone telecommunication/switching systems
- PDAs, PDA cradles, and other hand held devices
- Cellular phones and cell phone chargers

MEDIA

- Toner cartridges (ink jet and laser jet)
- CDs, DVDs, magnetic tape

BATTERIES

- Car
- Household

UNACCEPTABLE MATERIALS

Primarily, "electric" CONSUMER ELECTRIC ITEMS with a cord are not accepted at AERC's Electronics Recycling Events:

- Oscillating Fans
- Desk and Floor Lamps
- Small kitchen appliances (toaster, toaster oven, blender, mixer, etc.)
- Small handheld power tools
- Small personal cosmetic appliances (portable hair dryers, shavers, curling irons, etc.)
- Vacuum Cleaners
