## **Council Re-organization News**

At the Lower Saucon Township Council re-organization meeting on January 2, 2018, Council welcomed a new member and approved re-appointments to the Township Boards and Committees.

Ryan Stauffer (pictured to the left), who was elected to a four-year term in November, was sworn in by Township staff member and notary,

Diane Palik. Mr. Stauffer, who lives on Bucknell Circle in the Township with his wife Kristen, graduated from Saucon Valley High School, then stayed in the Lehigh Valley receiving his bachelor's degree from Muhlenberg College. He attended the University of California, Irvine, where he received his Juris Doctor, and upon graduation served as a Law Clerk for a judge in the U.S. District Court for the Middle District of Pennsylvania. He is currently employed at Gross McGinley, LLP in Allentown. Mr. Stauffer was appointed as Council liaison to the Parks & Recreation Board, the Saucon Creek Watershed, Hellertown Area Library Board and will serve as an alternate for the Saucon Valley Partnership.

In other business, also sworn-in was Glenn Kern, who was re-elected to his fifth term in November. Council elected Sandra Yerger as President and Priscilla deLeon as Vice President.

### Be In The Know With Nixle

Nixle offers notification services for local police departments, county emergency management offices, municipal governments and their agencies within the United States. The Nixle service allows government agencies to send messages to local residents via phone, email and web. Information is delivered almost instantly. Nixle serves government agencies and organizations in all 50 states.

Lower Saucon Township Public Works and Police Department both utilize Nixle to send out information pertaining to road closures, construction, lost and found pets, neighborhood crime and suspicious activities. Alerts can be set-up to go directly to your mobile phone or any digital device.

You can access Nixle by visiting <u>www.nixle.com</u> and enter your zip code. At the top of the page, click "Sign Up" and fill in the required fields and hit accept. You will receive a single opt in welcome message. Reply yes to continue to receive SMS text messages. You can opt out at any point by sending STOP to 888777. Send HELP to 888777 for Information.



## **Driving Tips from the LSTPD**

Remember, if winter weather is forecast, eliminate all unnecessary travel. This will keep you and your family safe and allow clean-up crews to more easily perform its winter duties.

#### WINTER DRIVING TIPS

- Carry a winter emergency travel kit.
- Listen to weather and travel advisories, but if you don't have to travel in bad weather, don't.
- Keep your gas tank at least half full.
- Slow down and increase following distance.
- Avoid sudden stops and starts.
- Beware of roads that may look wet, but are actually frozen, often referred to as "black ice".
- Use extra caution on bridges and ramps, where ice can often form without warning.
- Carry a cellphone.
- DO NOT use cruise control while driving on snow-covered roads.
- State law requires you to turn on your headlights when your wipers are on.
- Use your low beams in particularly bad weather, especially in cases of heavy or blowing snow.
- Remove ice and snow from windows, mirrors and all vehicle lights before you drive and as often as needed.
- Remove snow and ice from the hood and roof of your vehicle. State law states that if snow or ice from your vehicle strikes a vehicle or person and causes death or injury, you can be ticketed.
- DO NOT park or abandon your vehicle on snow emergency routes
- DO NOT pass or get between trucks plowing in a plow line (several trucks plowing side by side).
- Make sure someone else knows where you are going and when you expect to arrive. In case you run into an emergency and need help, someone will know where to look for you.
- If you do become stranded, it's better to stay with your vehicle until help arrives. Run the engine every hour or so, but make sure the tailpipe is clear and keep the downwind window cracked open.
- DO NOT drink and drive, and always wear your seat belt.
- Preparation is also key to successfully navigating winter roads. Winter weather can bring unexpected conditions, so make sure that both you and your vehicle are ready for ice and snow.

During the cold winter months, we like to warm up our vehicles.

- DO NOT leave a running vehicle unlocked and unattended.
- A remote car starter keeps your car locked and the keys in your pocket!

### **Curb & Sidewalk Maintenance**

# Who is responsible for clearing snow and ice from sidewalks?

According to Municipal Code of Lower Saucon Township (§ 140-17) property owners and occupants are responsible for keeping sidewalks clear of snow and ice.

#### Why should I care if my sidewalk is clear of snow and ice?

Many people rely on walking and transit as their primary source of transportation and without a wide, clear path through snow and ice, it is especially difficult for people with disabilities, seniors, and children to walk safely. We are all pedestrians and benefit from having a safe, clear, and continuous path to travel.



#### How long do I have to clear my sidewalk?

Within 36 hours of the termination of any fall of snow or accumulation of ice. Residents are also reminded not to throw snow from your sidewalks and driveway onto the roads.

# How much snow do I need to clear to comply with the Ordinance?

You should clear at least a 30 inch path along the sidewalk, where conditions allow. This width allows pedestrians in wheelchairs, people with children in strollers, students walking to school, and individuals with assistive devices mobility and access.

#### What happens if I don't clear my sidewalk?

Individuals and businesses who do not comply with the Curb and Sidewalk Maintenance ordinance can face fines of \$50 or more set upon by the District Magistrate. You are able to report violations to the Township by calling and reporting the full address 610-865-3291 or emailing zoning@lowersaucontownship.org.

# What happens if I am physically unable to clear my sidewalk of snow and ice?

As a property owner, while you may be physically unable to clear snow and ice from your sidewalk yourself, it is still your responsibility to ensure that sidewalks along your property are cleared. Consider hiring a contractor or asking a neighbor to help.

## **Mailbox Numbering**

Did you ever stop to think how easy it is to locate your house? If you placed a call through the 911 system and a first responder was sent to your home, would they be able to find it? Well, the key to a quick response in an emergency is proper identification. Many residents likely are not aware that the Township Code has specific requirements for identifying your home, specifically "Numbering of Buildings". Below are sections from Chapter 69 of the Township Code (available online).







The street address number shall be displayed in the following manner:

- A. General requirement The required displays of the street address number shall be in four Arabic numbers. Additional apartment and suite numbers shall also be established for multiple-tenant properties.
- B. Mailbox If there is a freestanding mailbox located on the property in a location that would readily identify the designated street address number, the street address number shall be placed on both sides of the mailbox or supporting structure or on both sides of an attached sign. Neat numbers not less than two inches high shall be used. If any requirements of this chapter conflict with requirements of the United States Postal Service, the Postal Service requirements shall govern.
- C. Front yard or building face In the event that there is no freestanding mailbox located on the property in a location that would readily identify the proper street address number or if the mailbox is located in a group of mailboxes or on a street other than that of the designated street address number, the street address number shall be displayed on the mailbox.
- D. Multiple-occupant buildings In the case where a building is occupied by more than one entity for residential or nonresidential purposes, the street address number shall be displayed in the manner indicated above. In addition to the normal display, the main entrance door to each occupied space shall display the apartment or suite number in characters at least one inch in height. This display to be located between four feet and six feet above the level of the floor outside the entrance door.

5.89 Mills (.00589) - (5.39 & Fire Appropriation .50)
Northampton County Real Estate Taxes –
11.8 Mills (.0118)

Saucon Valley School District Real Estate Taxes – 53.03 Mills (.05303)

Tax bills were sent out in early February. If a mortgage company pays your taxes, it is the *property owner's responsibility* to send the tax bill to your mortgage company.

Please note that Lower Saucon Township Council has approved the use of installment payments as of 2018. Please note due dates on your installments if you choose that option.

- Bingen Road between Black River Road & Friedensville Road
- Black River Road between Route 378 & Bingen Road
- Redington Road between Lower Saucon Road & Riverside Drive
- Flint Hill Road between Route 412 & Springfield Twp. line

## How to Recognize a Pipeline Leak

Use your senses of smell, sight and sound to identify a potential pipeline leak. Signs of a leak may include:



Dead or dying vegetation near the pipeline, oily sheen on water, pools of liquid on the ground near the pipeline, dirt or debris blowing into the air, fire or a dense white cloud or fog



#### SMELL:

Strong petroleum scent or other pungent odor, a smell similar to rotten eggs, or sulfur, if odorant is added



#### **SOUND:**

Hissing, gurgling or roaring sound

#### What to Do if a Leak Occurs

Take these steps to ensure your safety and the safety of others if a pipeline leak is suspected or detected:

- Leave the area immediately in an upwind direction.
  - Call 911.
- Call the Interstate Energy Company emergency number, 800-747-3375, to notify us of the location.
- Turn off any equipment and eliminate any ignition source, if able to do so without risk of injury.

#### What Not to Do if a Leak Occurs

- Do not come into direct contact with any escaping liquids or gas.
- Do not start any motor vehicles, electrical equipment or use cell phones while in the area.
  - Do not attempt to operate any pipeline valves.
    - Do not attempt to extinguish a petroleum product or natural gas fire.



## 10 Things You Can Do to Prevent **Stormwater Runoff Pollution**

- 1. Use fertilizers sparingly and sweep up driveways, sidewalks, and gutters.
- Never dump anything down storm drains or in streams.
- Vegetate bare spots in your yard.
- 4. Compost your yard waste.
- 5. Use least toxic pesticides, follow labels, and learn how to prevent pest problems.
- Direct downspouts away from paved surfaces; consider a rain garden to capture runoff.
- Take your car to the car wash instead of washing it in the driveway.
- Check your car for leaks and recycle your motor oil.
- 9. Pick up after your pet.
- 10. Have your septic tank pumped and system inspected regularly.

## PROTECT YOURSELF FROM HOME HEATING FIRES

Facts about home heating fires from the United Sates Fire Administration:

- From 2013-2015, an average of 45,900 home heating fires occurred in the United States each year. These fires caused an annual average of approximately 205 deaths, 725 injuries and \$506 million in property loss.
- Heating was the second leading cause of home fires after cooking.
- Home heating fires peak in the early evening hours between 5:00 p.m. and 9:00 p.m. with the highest peak between 6:00 p.m. and 8:00 p.m. This four-hour period accounted for 29 percent of all home heating fires.
- Home heating fires peaked in January (21 percent) and declined to the lowest point from June to August.
- Confined fires fires confined to chimneys, flues or fuel burners accounted for 75 percent of home heating fires.
- Twenty-nine percent of the non-confined home heating fires — fires that spread past the object of origin happened because the heat source (like a space heater or fireplace) was too close to things that can burn.

#### SAUCON VALLEY COMPOST CENTER

#### **Compost Center ID Cards**

The laminated multi-year ID card will continue to be used at the Compost Center. Residents who need a new or replacement ID card can pick them up at the Borough or Township offices during regular business hours.

The ID cards should be displayed to the gate attendant when you visit the Compost Center and can be used by all members of the residence it is issued to. The Compost Center reserves the right to confirm the identification of the card holder, if there is a suspicion that the card is being misused for non-resident or commercial purposes.

#### Contractors

Landscaping contractors hired by a resident of Hellertown Borough or Lower Saucon Township may drop off brush/yard waste/leaves only with a signed invoice and/or the resident's ID card.

#### **Tarping Requirements**

Visitors to the Center are reminded that per Pennsylvania State Law all loaded trucks or trailers must be covered with a tarp when traveling on any public road and when dropping off or picking up materials at the compost center.

#### Volunteers Needed

The Saucon Valley Compost Center is recruiting volunteers to assist with the operation of the Center. Due to municipal funding limits, operating hours of the Compost Center cannot be extended beyond the current schedule at this time. However, expanded hours could be considered in the future if more volunteers step forward to assist at the facility. If you are interested in volunteering your time to help out at the Center, please contact the Township at manager@lowersaucontownship.org or the Borough at c.hartranft@hellertownborough.org.

## A Honor for Ron



Council honored Ronald Horiszny on January 17<sup>th</sup> as his term came to an end. He served the citizens of Lower Saucon Township for over 12 years as a Township Council Member, first being appointed on June 1, 2005 to fill a vacant seat, then being elected for three consecutive four-year terms beginning January 1, 2006, and serving as
