## RESOLUTION # 57-2021

### RESOLUTION OF THE COUNCIL OF LOWER SAUCON TOWNSHIP AUTHORIZING THE SUBMISSION OF A 2021 NORCO GROW GRANT FOR THE PURCHASE OF POLICE SPEED ALERT AND MESSAGE SIGNS

**WHEREAS**, Lower Saucon Township provides for speed enforcement and motorist safety on Township roads; and

**WHEREAS**, Lower Saucon Township employs several methods in deterring speeding and notifying the community of road safety issues, such as closures and work being done; and

**WHEREAS**, the Lower Saucon Township Police Department desires to be able to relay information to the public while traveling within the Township; and

**WHEREAS**, electronic signage provides effective safety information and help educate the motorists while also capturing data to evaluate and enhance ongoing safety measures; and

**WHEREAS**, the Saucon Creek separates the Township causing natural impediments; potentially life threatening when storms occur and also creates hazardous conditions in the Township and with our Hellertown Borough neighbors.

**NOW, THEREFORE, BE IT RESOLVED**, that the Council of Lower Saucon Township, Northampton County, Pennsylvania hereby approves the submission of a 2021 GROW NORCO Grant Application to the Northampton County Community and Economic Development for the purchase of radar speed alert and safety messaging signs for the Lower Saucon Township Police Department in the total amount of \$50,000.00 with the Township's commitment in the amount not to exceed of \$18,000.00 and the grant portion, if awarded in the amount of \$32,000.00; and,

**BE IT FURTHER RESOLVED**, that the Council of Lower Saucon Township does hereby designate Sandra B. Yerger, Council President, and Leslie Huhn, Township Manager, to execute all documents and agreements between Lower Saucon Township and the Commonwealth Financing Authority to facilitate and assist in obtaining the requested grant.
