### Update Monday, April 20, 2020

Lower Saucon Township is operating under a Declaration of Disaster Emergency and Council and our Administration are working closely to make sure essential government functions continue and resources are available for our residents. The Township offices are closed to the public, staff is reporting to the office on a rotational basis, answering phones, processing mail and addressing emergencies as they arise. Employees have been provided access to their office computers and are able to work remotely as well. Tax payments are being processed and continue to be accepted – through a drop box at the Township, USPS, at the financial institutions (based on their hours) and online. The Public Works Department is also reporting on a rotational basis, with one person assigned per vehicle. They are responding to emergency calls and any other issues that arise. ### **Emergency Agriculture Assistance Grants**

The GIANT Company announced a \$250,000 emergency grant program in partnership with Team Pennsylvania to support small businesses in the state's food supply chain. Eligible businesses include family farms, small manufacturers, processing plants, and local food artisans. The GIANT Company and Team Pennsylvania worked with the Pennsylvania Department of Economic and Community Development, the Pennsylvania Department of Agriculture, the Pennsylvania Chamber, and Pennsylvania Food Merchants Association to develop the program. Just a reminder that distribution of meals will change permanently to Monday and Wednesdays only. Meals will be distributed on Monday for Monday and Tuesday. Meals distributed on Wednesday will be for the remaining three days.

### **Information Shared Below with No Changes:**

The Rain Barrel Workshop scheduled at Seidersville Hall for April 25, 2020 has been cancelled.

Commonwealth Extends School Closure for the Remainder of the Academic Year. Governor Tom Wolf has announced that all schools will remain closed for the remainder of the 2019-2020 academic year. The Governor made the decision in consultation with Secretary of Health Dr. Rachel Levine and Secretary of Education Pedro A. Rivera.

On April 1, 2020, Governor Wolf expanded the stay-at-home order to include the entire commonwealth. On April 3, 2020, Governor Wolf announced that as many people as possible should wear a nonmedical or homemade mask when leaving their homes.

This order took effect at 8 p.m., Monday, March 30, 2020, and will continue until April 30. All stay-at-home orders are now extended through April 30. All Pennsylvania schools will remain closed until further notice. Non-life-sustaining business closures remain in effect.

Individuals may leave their residence only to perform any of the following allowable individual

activities and allowable essential travel:

- Tasks essential to maintain health and safety, or the health and safety of their family or household members (including pets), such as obtaining medicine or medical supplies, visiting a health care professional, or obtaining supplies they need to work from home
- Getting necessary services or supplies for themselves, for their family or household members, or as part of volunteer efforts, or to deliver those services or supplies to others to maintain the safety, sanitation, and essential operation of residences
- Engaging in outdoor activity, such as walking, hiking or running if they maintain social distancing
- To perform work providing essential products and services at a life-sustaining business
- To care for a family member or pet in another household
- Any travel related to the provision of or access to the above-mentioned individual activities or life-sustaining business activities
- Travel to care for elderly, minors, dependents, persons with disabilities, or other vulnerable persons
- Travel to or from educational institutions for purposes of receiving materials for distance learning, for receiving meals, and any other related services
- Travel to return to a place of residence from an outside jurisdiction
- Travel required by law enforcement or court order
- Travel required for non-residents to return to their place of residence outside the commonwealth
- Anyone performing life-sustaining travel does not need paperwork to prove the reason for travel.

The following operations are exempt: Life-sustaining business activities

- Health care or medical services providers
- Access to life-sustaining services for low-income residents, including food banks
- Access to child care services for employees of life-sustaining businesses that remain open as follows: child care facilities operating under the Department of Human Services, Office of Child Development and Early Learning waiver process; group and family child care operating in a residence; and part-day school age programs operating under an exemption from the March 19, 2020 business closure Orders
- News media
- Law enforcement, emergency medical services personnel, firefighters
- The federal government
- Religious institutions

Individuals experiencing homelessness are not subject to this order but are strongly urged to find shelter and government agencies are urged to take steps needed to provide shelter for those individuals.

International students, foster youth, and any other students who would otherwise experience displacement or homelessness as a result of campus closures are exempt and may remain in campus housing. The Department of Education will be providing updated guidance and resources on the continuity of education for students to schools in the coming days.

At this time, law enforcement will be focused on ensuring that residents are aware of the order and informing the public of social distancing practices rather than enforcement. To report a noncompliant business, contact your local law enforcement agency's non-emergency number or the nearest Pennsylvania State Police station. Please do not call 911 or the Department of Community and Economic Development to file reports.

Law enforcement officers should refer to any travel related to the provision of or access to the above-mentioned individual activities or life-sustaining business activities.

Our Police Department has planned for this situation and have been taking proactive measures to protect our officers and the residents we serve. **For all emergency calls, please call 9-1-1.** For all non-emergencies that do not require a police response an officer will call you and then complete the report after gathering the necessary information. If the non-emergency all requires a police response to your residence or business, an officer will phone you in advance and request you to step outside, if possible. PennDOT extended expiration dates on Driver Licenses, ID Cards, Vehicle Registrations and Other Products. See press release from PennDOT below:

Harrisburg, PA – The Pennsylvania Department of Transportation (PennDOT) announced today that expiration dates for driver licenses, identification cards, learner's permits, persons with disability placards, vehicle registrations and safety and emission inspections will be extended for Pennsylvania residents in response to statewide COVID-19 mitigation efforts.

- Deadlines on the following products will be extended effective March 27, 2020: Driver licenses, photo ID cards and learner's permits scheduled to expire from March 16, 2020 through April 30, 2020, the expiration date is now extended through May 31, 2020.
- Vehicle registrations, safety inspections and emissions inspections scheduled to expire from March 16 through April 30, 2020, the expiration date is now extended through May 31, 2020.
- Persons with Disabilities parking placards scheduled to expire from March 16 through April 30, 2020, the expiration date is now extended through May 31, 2020.

**Wednesday, April 1, was Census Day!** As a reminder, Census Day is a key reference date for the 2020 Census that is observed nationwide, but Census Day is not like Election Day — **respondents can still respond after Wednesday, April 1st.** In fact, if a household hasn't responded yet online, they'll get a paper form in the mail starting next week.

The Wolf Administration Reminds Pennsylvanians to Respond to the 2020 Census. The Department of Community and Economic Development (DCED) Secretary Dennis Davin reminded all Pennsylvanians to be a good neighbor and respond to the 2020 Census. "We're committed to working together to make sure all Pennsylvanians are counted in the Census," said Sec. Davin. "Now more than ever, our representation and billions of dollars of funding for critical resources depend on an accurate count of all Pennsylvanians, no matter who they are or where they live."

This year marks the first time in history that responses can be filled out online. It has never been easier for Pennsylvanians to respond online, by phone, or by mail.

The Census questionnaire is simple and confidential, with questions that include your name, address, sex, race, ethnicity, age, and whether you own or rent your home. The Census Bureau will

never ask about your citizenship status, or for sensitive information like your social security number, bank accounts, or payments/donations. The Census Bureau will never reach out to you on behalf of a political party. Your responses to the Census are protected by law and cannot be shared with, or used by, any other government agencies. Answers cannot be used for law enforcement purposes or to determine eligibility for government benefits or immigration enforcement.

The United States Constitution requires a Census count once every 10 years and counts every person living in the United States once and only once. The results of the 2020 Census will help provide fair representation when determining congressional districts, policy, decision-making, and distribution of billions of dollars in federal funding that impacts the daily lives of Pennsylvanians over the next 10 years.
