ORDINANCE NO. 2007-10

AN ORDINANCE OF THE TOWNSHIP OF LOWER SAUCON, COUNTY OF NORTHAMPTON, COMMONWEALTH OF PENNSYLVANIA AMENDING AND REVISING CHAPTER 170, VEHICLES AND TRAFFIC, OF THE CODE OF THE TOWNSHIP OF LOWER SAUCON TO PROVIDE FOR THE ADDITION OF A NO PARKING SIGN ON THE WEST SIDE OF PA ROUTE 412 AT MEADOWS ROAD AND A NO LEFT TURN SIGN AT THE INTERSECTION OF MEADOWS ROAD AT PA ROUTE 412

WHEREAS, the Township of Lower Saucon has adopted Chapter 170 of the Code of Lower Saucon Township (hereinafter "Code") relating to vehicles and traffic; and

WHEREAS, the Township of Lower Saucon desires to amend Chapter 170, Vehicles and Traffic, at §170-13 of the Code for the purpose of adding a "No Parking Any Time" sign on the West side of PA Route 412, one hundred (100') feet North of the intersection of Meadows Road; and

WHEREAS, the Township of Lower Saucon also desires to amend Chapter 170, Vehicles and Traffic, at §170-27 of the Code for the purpose of adding a "No Left Turn" restriction sign for Meadows Road at the intersection of PA Route 412; and

WHEREAS, the Township has complied with all applicable pre-requisites and/or requirements under the law with regard to the installation of traffic devices; and

WHEREAS, the adoption of this Ordinance shall promote the health, safety, comfort, convenience, and general welfare of the citizens of Lower Saucon Township.

NOW THEREFORE, BE IT ORDAINED AND ENACTED BY THE Council of the Township of Lower Saucon, County of Northampton, and Commonwealth of Pennsylvania as follows:

SECTION 1

The foregoing Whereas clauses are incorporated herein the same as if set forth herein again at length.

SECTION 2

Chapter 170, Vehicles and Traffic, at §170-13 of the Code of the Township of Lower Saucon regarding no parking signs is hereby amended to include insertion of the following additional information:

Chapter 170-13. Parking Prohibited at all times in certain locations

Highway	Side	Between
PA Rt. 412	West	100 feet north of the intersection of
		Meadows Road and PA Rt. 412

SECTION 3

Chapter 170, Vehicles and Traffic, at §170-27 of the Code of the Township of Lower Saucon regarding left turns prohibited signs is hereby amended to include insertion of the following additional information:

Chapter 170-27. Left turns prohibited

B. Left turn restriction for Meadows Road at the intersection of SR 0412.

SECTION 4

<u>Severability</u> – The provisions of this Ordinance are severable. If any sentence, clause, or Section of this Ordinance is for any reason found to be unconstitutional, illegal, or invalid; such Decision shall not affect the validity of any of the remaining provisions of this Ordinance. It is hereby declared as a legislative intent that this Ordinance would have been adopted had such unconstitutional illegal or invalid provision not been included herein.

SECTION 5

<u>Repealer</u> – All ordinances and parts of ordinances inconsistent herewith are hereby repealed.
