RESOLUTION #28-2024

**A RESOLUTION ESTABLISHING APPLICATION AND ESCROW FEES, PERMIT FEES,
UNIFORM CONSTRUCTION CODE FEES, FEES FOR THE USE OF FACILITIES, AND
OTHER FEES FOR SERVICES PROVIDED BY LOWER SAUCON TOWNSHIP**

WHEREAS, Lower Saucon Township is authorized pursuant to the Code of the Township of Lower Saucon, the Second Class Township Code, the Pennsylvania Municipalities Planning Code, the Uniform Construction Code, and other applicable statutes to establish a schedule for certain fees that are to be paid to the Township General Fund for the submission of applications, the use of Township facilities, the acquisition of permits, the provision of financial and tax services and police department services, fees associated with Right-to-Know Act requests, and other authorized and associated fees; and

WHEREAS, these fees are to be established to provide for general reimbursement to the Township General Fund for administrative costs associated with processing applications and permits, maintaining facilities, scheduling and reserving Township fields and pavilions, as well as other incidental costs; and

WHEREAS, the Township of Lower Saucon is desirous of establishing a uniform Fee Schedule for such applications, permits, and other enumerated services so that the general administration costs associated with the provision of these services are specifically set forth and established.


NOW, THEREFORE, be it resolved and it is hereby resolved as follows:


